During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly, by means of direct tapping from incoming side of service cable

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1. 1 no Electric heater - 1500 watt
2. 3 nos Fan - 80x3 = 240 watt
3. 1 nos TV - 120 watt
4. 6 nos CFL - 20x6 = 120 watt

Out of which we seized the following:

1 nos energy meter with tapping service cable. (meter no - L4374721)

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list.

The inspection team left the above premises at about 4.30pm on dated 05.02.2020. The accused person has committed an offence U/S-135(i)(b) of the Electricity (Amendment) Act-2007.
