Entered the premises of SUNIL KR DEOGHARIA S/O- Late BHOLANATH DEOGHARIA of Village- ANARA , P.O- ANARA , P.S- PARA , Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct tapping from incoming side of service cable
(Meter No - B3974477)
(Consumer NO - 242015932)

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① LED LIGHT - 4 NOS (48 watt) ② FRIDGE - 2 NOS - (360 watt)
- ③ FAN - 3 NOS - (240 watt) ④ TV - 1 NO - 120 watt

Out of which we seized the following:

- ① One no. energy meter (B3974477) with tapping service cable approx 5m.
