and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (a) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Lamp 100 watt each - 02 (Two) Nos.
- 2) Lamp 60 watt each 02 (Two) Nos.

Out of which I seized the following.

- 1) Single core PVC cable approx-24 (Twenty four) Mtr. with hooking device.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 02:15 PM on 12-02-2020. The accused person has committed an offence U/S135(I) (a) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
