and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I) (a) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

17 Lamp. 100 W each - 0.2 (Two) nos.

Out of which I seized the following.

17 Two core flexible cable - Approx. 10 (Ten) meter
with hooking device.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 22.00 PM on 12.02.2020. The accused person has committed an offence U/S135(I) (a) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.
