Today, i.e. on 11.02.2020 I, Prashant Kishor (AE&SM), along with Prashant Kishor,A.E. ,Chinmoy Maity,JE(Gr-1) of Telkalpara CCC ,Jaiur Rahaman Mondal,DE(S&LP) & Sankar Chandra Mahato,ACM of Purulia Region ,WBSEDCL conducted a raid programme. at village Bongabari under Purulia(M) P.S. When our team at about 01.40P.M. entered to the Domestic premises of Tanmoy Chandra, we found that he was enjoying electricity dishonestly by means of Meter bypass by tampering service cable and run Domestic appliances, thus WBSEDCL losses revenue .As theft of electricity was detected in presence of the representative and meter with bypass service cable seized and seizure list prepared at the site and acused person representative signed on the seizure list and others related papers .The seized material labelled in presence of the representative. The inspection team left the aforesaid location at about 02.00 P.M. on 11.02.2020 after completion of inspection & necessary formalities.
