- 2) That on 28/11/2019 the complainant parked his vehicle in the Petrol Pump at Village – Gengara, P.S. Purulia (M), District – Purulia, and about 8.00 P.M he came to know that his vehicle (TRUCK NO. WB 49N/0297) has been stealing away by some miscreants from the said petrol pump.
- 3) That it is to be mentioned here the complainant very recently (three months ago) changed all the old ten pieces of tyres by replacing new tyres by expending around Rs. 1,50,000/- .
- 4) That your complainant came to know from reliable source that the vehicle was stolen by the accused persons named in this petition i.e. 1) MD. Lai S/O.Lt. MD. Rafiq 2) MD. Faizal S/O. MD. Lal, both are resident of Kasai Mahalla, P.O. Purulia, P.S. Purulia (T), and District – Purulia.
- 5) That complaint also begs to inform that the accused persons are known as scarp dealer doing business of scrap materials and he also apprehend that the accused persons may sale off his entire truck by disassembling all the parts of the vehicle and rest of the body as scrap materials.
- 6) That the complainant inform the matter to the I.C. Purulia (M) P.S. on the same day and finally refused to registered any complaint against the accused persons.
- 7) That your complainant on 4.12.2019 sent the typed complaint before the I.C. Purulia (M) P.S. on 2.12.2019 through registered post and as no action has been taken to recover the vehicle from the clutch of the accused persons and having no other option your complainant inform the matter to S.P. Purulia on 6.12. 2019 and till date no steps has been taken to recover the Truck of the complainant.
- 8) That having no other options left to him the complainant compelled to lodge this complaint u/s 156 (3) of the Cr. P.C. before this Ld. Court. Seeking proper remedy against the accused persons as such to get return of his stolen truck no. WB 49N/0297.

It is therefore prayed that your honour may graciously be pleased to admit this Misc. Petition and treating the same as a F.I.R. u/s 156(3) of Cr.P.C. be pleased to direct the I.C. Purulia (M) P.S. to investigate the case properly as alleged.
