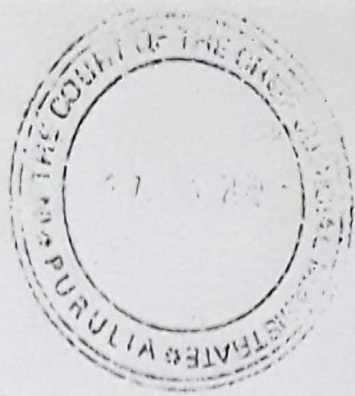

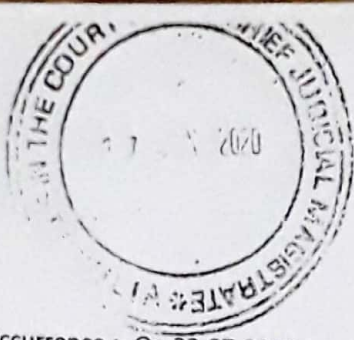

4. Occurrence :- On 23-07-2018 corresponding to 6<sup>th</sup>. Day of Ashar 1425 B.S. at village Chandradih , P.S. Purulia (M), District Purulia and onwards .

5. Offences :- U/S 420/406/34, 506/34 I.P.C. .

The above named complainant begs to state  
as follows:-

- 1---That your petitioner , the witnesses, and the accused persons are the residents of the same village Chandradih , under P.S. Purulia (M) , District Purulia and neighbour to each others .
- 2---That your petitioner is the owners of the land mentioned as in the schedule below .
- 3---That on 24-07-2018, the owners of the lands namely Saram Gope, Dhanapati Gope , Nimai Gope, Praksh Chandra Gope , Ramanath Gope , Dilip Gope, Purnima Gope , Pashupati Gope , Sitaram Gope as mentioned in the schedule below transferred and sold the lands to the petitioner by registered sale deed vide No, 3975 dated 24-07-2018. Thereafter your petitioner / complainant took exclusive possession of the lands without any dispute .
- 4---That it may be mentioned here that late Khepu Gope , Bhutu @ Ananda Gope and Sitaram Gope of Chandradih , P.S. Purulia (M) , were the previous owners of the lands in question and after their demise the above named Saram Gope and 8 others became the owners of the lands in question who sold out the same to the complainant .In this respect Pradhan of the of Chakoltore Gram Panchayat issued legal heir certificate in respect of the persons who sold out the properties on 23-07-2018, and mentioned in the Certificate that the above named vendors were / are the only legal heirs and none else.
- 5---That on that score and good faith your complainant purchased the schedule properties valued at Rs. 5,13,986/- paid the entire amount in which the vendors issued receipt in favour of your complainant.
- 6---That later on your complainant come to know which was suppressed by the above mentioned vendors that apart from those vendors Nunibala Gope, Malati Gope , Rakhi Gope , Kalabati Gope , Mantu Gope were the co sharers of the aforesaid property which was suppressed by the above mentioned vendors .

7---That it is crystal clear that the above mentioned vendors after making conspiracy with Nunibala & others this fraudulent deed has been made to grab the amount from the complainant illegally and transfer the schedule property to your complainant after making conspiracy by suppressing the truth the above mentioned transferors sold the property of the other co sharers also namely Nunibala Gope, Malati Gope, Rakhi gope Kalabati Gope and Mantu Gope and they realised the amount of other sharers also and realised the entire amount from the complainant with saying the accused persons 1 to 9 namely Saram Gope, Dhanapati Gope, Nimai Gope, Prakash Chandra Gope, Ramanath Gope, Dilip Gope Purnima Gope Pashupati Gope Sitaram Gope that the accused persons are the only legal heirs and owners of the property and none else.

8---That due to such conspiracy and suppressing of fact there has been wrongful loss to your complainant whereas there has been wrongful gain of the accused persons. The accused persons in furtherance of their common intention have cheated your complainant and grabbed the amount i.e. Rs. 5,13,968/-.

9---That after sale of the property all the above named accused persons are threatening your complainant with dire consequences and forcibly trying to dispossessed the complainant from the schedule land as mentioned in the schedule below.

10---That your complainant reported the matter to the Officer in Charge Purulia (M) Police station as well as the Superintendent of Police Purulia but of no good though the accused persons committed the offence punishable U/S 420/406/34,506/34 I.P.C. .

11---That your complainant is a very poor man. He is helpless having no source of income whatsoever. He is not in a position to conduct the case on his own expense. Moreover, there are some technical and legal aspects involved in this case which also requires considerable money and machinery. For all these, it is highly desirable that this case should be converted to a police case for thorough Police investigation.

It is prayed that your Honour may be graciously

Pleased to direct the Officer -In Charge Purulia (M) Police Station to investigate the case in accordance with law, treating the same as F.I.R., as contemplated U/S 156(3) Cr.P.C.
