In Sinducing herewith the accused person namely (1) Samim Ansari (56 yrs) s/o Lt Moinuddin Ansari of ovpur Sadagar para, PS- Joypur, Dist- Purulia, under arrest and seized articles (1) One white coloured plastic bag with 06.00 KG Cannabis/Ganja (2) 03 brown coloured envelope containing 100 gm each of loose Cannabis/Ganja which have been collected from said bag as sample under proper seizure list, sealed and labeled, duly signed by the witnesses and accused persons, I, SI Dipankar Sarkar, O/C Purulia (T) PS, do hereby lodge complaint as suo-motu against the above noted accused person for committing an offence punishable U/S 20 (b)(1)/29 NDPS Act 1985. Today (06.02.2020) at 14:45 hrs, received a reliable source information that one drug peddler namely Samim Ansari (56 yrs) s/o Lt Moinuddin Ansari of Joypur Sadagar para, PS- Joypur, Dist- Purulia, is coming near Purulia Bus stand area.

The source also informed that he was carrying one plastic bag containing Cannabis/Ganja in his hand. I noted the fact in G.D. vide Purulia (T) PS GDE No 325 dtd 06.02.2020, informed the matter to CI Sadar, Purulia & Dy. SP (HQ), Purulia, and other Superior Officers of Purulia District. As per their direction myself along with my source, ASI Ajoy Mukhopadhyay, C/983, Radhakanta Kisku, JC/1263, Tarun Sahu, JC/386, Sourav Kr Sahoo, JC/43, Uttam Man, vide Purulia (T) PS GDE No 326 dtd 06.02.2020 & C.C. No. 331/20 dtd 06.02.2020 left for Purulia bus stand area to work out the information by Govt. vehicle having Reg. No. WB 56C 0800 also carried seal, gala, match box, candle, brown paper, weighing instruments.

Today, i.e. 06.02.2020 at 15:25 hrs reached near Purulia Bus stand area adjacent to Registry Office within a visible distance of place of assembly of suspect & got down from the vehicle, kept the vehicle at bus stand. At about 15:35 hrs one person identified as Samim Ansari by source with white coloured plastic bag in his right hand arrived at that place. We watched him for a considerable period, meanwhile, I along with accompanied officers & force disclosing our identities surrounded him & also detained him with the said bag. Being asked, he disclosed his identity as Samim Ansari (56 yrs) s/o Lt Moinuddin Ansari of Joypur Sadagar para, PS- Joypur, Dist-Purulia. On interrogation, he confessed that, said bag contained Cannabis/Ganja. He also stated that he was carrying the same for selling at Purulia town area. I informed the matter to CI, Sadar, Purulia and Dy. SP (HQ) Purulia. Thereafter, I issued notice to the accused person asking him whether he is willing to be searched by me in presence of an Executive Magistrate or a Gazetted Officer. In reply of the notice, the detained person gave his willingness in writing to be searched in presence of an Executive Magistrate, accordingly informed to Sri Dibyajyoti Das, BDO Purulia- I Dev Block (Executive Magistrate) with a request for search and seizure as per provision of section 50 of NDPS Act. Meanwhile, we searched for public witnesses with the help of accompanied officer & force. After a while one public witness namely Rasid Sadagar @ Bhaglu s/o Lt Rouf @ Madan Sadagar of Ladhurka, PS- Hura, Dist- Purulia, became ready to assist us in conducting search & seizure. Within half an hour CI Sadar, Purulia and BDO Purulia-I Dev Block, arrived at the spot and disclosed their identity and explained the reason for arriving there. After their arrival I started search & seizure process at PO. Then I offered the said detained person to search our persons before get him searched. Accordingly he conducted search of our persons but nothing was found except our official belongings and accordingly, I prepared NIL seizure list in presence of Sri Dibyajyoti Das, B.D.O Purulia-I Dev Block and detained person. At first myself with the help of officers and force searched Samim Ansari and his belonging at the spot. During search of him found one white coloured plastic bag loaded with 06.00 KG Cannabis/Ganja. Thereafter as per direction of BDO Purulia-I Dev Block, I opened some portion of bag and found Cannabis/Ganja in that bag. Accordingly I seized the said bag under proper seizure list duly signed by the public witness, police witnesses and accused person in presence of BDO Purulia-I Dev Block. Also packed, sealed and labeled the same at the PO with the help of accompanied officers and force and made over one copy of seizure list to the accused person. The Cannabis/Ganja is prohibited narcotic drugs which he was dealing in lieu of money that violating Sec. 20(b)(i)/29 NDPS Act 1985. There is no question of having any license in respect of possessing the same, accordingly I arrested him, informed him ground of arrest, prepared memo of arrest and maintained all formalities regarding arrest. Total process of arrest, search, seizure, sealing and labeling were done between 16:05 hrs and 17:55 hrs under direct supervision of BDO Purulia-I Dev Block and CI Sadar, Purulia.

So I started Purulia (T) PS Case No 15/2020 dated 06.02.2020 U/S 20(b)(i)/29 NDPS Act 1985, as Suo-motu against the accused persons namely Samim Ansari (56 yrs) s/o Lt Moinuddin Ansari of Joypur Sadagar para, PS- Joypur, Dist- Purulia and directed SI Ramu Gurung of Purulia (T) PS for its investigation.
