I do hereby lodge complaint empowered by enabling The Electricity Act-2003, Subsequently Electricity (Amendment) Act-2007 to the effect that Kalipada Tantubug (Present User) was enjoying electricity unauthorisedly i.e bypass of energy meter by cutting of incoming service connection cable and due to this reason he has committed theft of electricity U/S 135(1)(b) The Electricity (amendment Act-2007).
