To The Inspector – in charge Raghunathpur P.S.

Sir,

In producing herewith the arrested accused person namely Somraj Nunia (23 Yrs) S/o Rajindar Nunia of Chinakuri Nunia Basti, Near Hanuman Mandir, PS - Kulti, Dist.- Paschim Bardhaman alongwith seized articles one improvised country made one shutter fire arms and one round live ammunition to the effect that on 19/20.02.2020 I, SI Debabrata Chakraborty along with C/1057 Albinash Tirkey, C/985 Laxman Ch. Majhi and C/844 Tufan Swadagar of Raghunathpur PS were engaged in Night Patrolling Duty at Raghunathpur PS area vide Raghunathpur PS GDE No 855 dtd 19.02.2020 and CC No. 560/2020. On 20.02.2020 at about 00:15 hrs received a credible source information that one person being equipped with fire arms, moving near to Sanka Rly. Gate on Purulia - Barakar pitch road (SH-5) with ill motive. I also took descriptions of the person.

Accordingly I informed the matter to IC, Raghunathpur PS and as per his kind direction I left to work out the information. On way I briefed my accompanied staff about the information and descriptions of that person and the mode of action to be done during detention. At about 00:35 hrs. dated 20.02.2020 we reached near to Sanka Rly. Gate on Purulia - Barakar pitch road (SH-5) and keeping our vehicle in a safe distance, we slowly moved to the information place and found said person was standing in-front of Bus Stoppage at Sanka Rly. Gate and we able to apprehended him and on being suspicion I searched the said person and found one improvised country made one shutter fire arms loaded with one round live ammunition was kept in his left side of the waist under is full pant. On demand of papers he failed to produce any papers / documents in support of carrying / possessing such fire arms and ammunition. On interrogation he disclosed his identity as noted above and made incoherent statement in respect of his presence at that place and also the purpose of possessing said fire arms and ammunition. So, it is reasonable to believe he choose the said alone place pre-plainly to commit any grievous offence against ongoing vehicle etc. on Purulia - Barakar Road. So finding no any other alternative way and after observing all the formalities I seized the said fire arms and ammunition under a proper seizure list in presence of witnesses as well as the accused person and also labeled the same. I tried my label best to sign the public witnesses but as the time is dead in night and in alone place and far distance from villages so none present there, So I unable to put signature of any public witnesses on the seizure list. Hence, I arrested him issuing memo of arrest as he is violated the Arms Act 1959.

I therefore pray that a specific case may kindly be started against the accused person namely Somraj Nunia (23 Yrs) S/o Rajindar Nunia of Chinakuri Nunia Basti, Near Hanuman Mandir, PS - Kulti, Dist.- Paschim Bardhaman under proper section of law and arrange its regular investigation.
