Entered the premises of Kanai Mandal, s/o- Lt Manohar Mandal, vill. + P.O- Godi Bero,  
P.S- Raghunathpur, Dist - Purulia, having Consumer Id- 200151076, Meter

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she  
was using electricity dishonestly by taping the incoming cable of the energy meter installed in the said  
premises and therefore bypassing the energy meter of W.B.S.E.D.C.L. i.e. U/S 135 (1)(b) was detected.
