I do hereby lodge complaint empowered by enabling The Electricity Act-2003, Subsequently Electricity (Amendment) Act-2007 to the effect that Kanai Mandal was enjoying electricity unauthorisedly i.e. bypass of energy meter by cutting of incoming service connection cable and due to this reason he has committed theft of electricity U/S 135 (1)(b) of the Electricity (amendment Act-2007).

During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by taping the incoming cable of the energy meter installed in the said premises and therefore bypassing the energy meter of W.B.S.E.D.C.L. i.e. U/S 135 (1)(b) was detected.
