Entered the premises of Bapin Karmakar, S.O- H Sudar Karmakar,

inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by initial bypassing from incoming service cable before energy meter.

Supply i.e. U/S 135 was detected.
