In producing here with one arrested accused namely Kevin @ Rana Das Modak (23 Yrs) S/O Ranjit Das Modak of Vill- D.S Colony near Durga Mandir, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 14 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-35 of each bottle.

I ASI Parimal Tewary of Adra PS do here by lodged a complaint against accused namely Kevin @ Rana Das Modak (23 Yrs) S/O Ranjit Das Modak of Vill- D.S Colony near Durga Mandir, PS-Adra, Dist- Purulia to the effect that on 08/03/20 at about 20:15 hrs in course of my special mobile duty I received a telephonic information from a reliable source that one Kevin @ Rana Das Modak (23 Yrs) S/O Ranjit Das Modak of Vill- D.S Colony near Durga Mandir, PS-Adra, Dist- Purulia has been stocked of country spirit illegally at his dwelling house/shop and selling the same to hike price for his personal gain. After getting such information I informed to my O/C and as per his direction I along with my accompanied force reached at D.S Colony at about 20:45 hrs. and hold raid in the house of said Kevin @ Rana Das Modak and found that the said person selling liquor at his house/shop and after seeing the Police party some person fled away and said Kevin @ Rana Das Modak has try to concealed himself but I able to apprehend him with help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Kevin @ Rana Das Modak selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Kevin @ Rana Das Modak (23 Yrs) S/O Ranjit Das Modak of Vill- D.S Colony near Durga Mandir, PS-Adra, Dist- Purulia under proper section of law.
