Sir,

In producing here with one arrested accused namely Ananda Soren (35 Yrs) S/O Rabi Soren of Vill- Kuldi, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 12 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-35 of each bottle.

I ASI Parimal Tewary of Adra PS do here by lodged a complaint against accused namely Ananda Soren (35 Yrs) S/O Rabi Soren of Vill- Kuldi, PS-Adra, Dist- Purulia to the effect that on 10/03/20 at about 20:15 hrs in course of my special mobile duty I received a telephonic information from a reliable source that one Ananda Soren (35 Yrs) S/O Rabi Soren of Vill- Kuldi, PS-Adra, Dist- Purulia has been transporting of country spirit illegally near Metyal Sahar village. After getting such information I informed to my O/C and as per his direction I along with my accompanied force reached at Metyal Sahar village at about 20:45 hrs and I found one person walking towards Metyal Sahar Rail gate and caring a plastic bag in his hand on search I found that the said person caring 12 bottles of DIL KHUSH 80 Up country spirit in a plastic bag for purpose of illegal transporting. I asked him to produced valid License or valid papers for the said country spirit but he failed to produce any valid license or documents for transporting /selling the same. So it is sufficient reason to believe that said Ananda Soren transporting the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Ananda Soren (35 Yrs) S/O Rabi Soren of Vill- Kuldi, PS-Adra, Dist- Purulia under proper section of law.
