I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Sukdeb Singh Sardar S/O-LT. Nakul Singh Sardar, Vill.-Daulatpur, PO-Gagnabad, PS- Adra Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 18.03.2020 I received a secret complain over telephone that Sri Sukdeb Singh Sardar S/O-LT. Nakul Singh Sardar, Vill.-Daulatpur, PO-Gagnabad, PS- Adra Dist-PURULIA consuming electricity by means of hooking from nearest It line of WBSEDCL.

On the basis of said complaint at about 3.10 pm. I, Sri MrinalChowdhury, Divisional Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL alongwith

- 1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
- 2) Sri Sanjoy Garain, OE, Kashipur CCC.

Entered the premises of Sri Sukdeb Singh Sardar, during inspection it has been found that he is consuming electricity dishonestly by means of hooking.

Total Load found approx 0.16 KW (Bulb-02 nos)

Then we disconnect his hooking line and seized the following articles.

- 1) Hooking wire with hooking device-06 mt.(approx)
2. Bulb With Holder-1 no.

After preparation of proper seizure list The seizure list are prepared at the site and the representative of accused person refuse to sign in the seizer list. The inspection team left the above premises at about 3.25 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
