Entered the premises of Irashad Ansary, s.o. Lt. Munamia Ansary of Village-Gopinath Pur, P.O- Sanka, P.S- Adra, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by illegal Bypassing from incoming service cable before Energy Meter.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) E-Rickshaw (Toto) = 1 No's = 760 watt

Out of which we seized the following: Single Phase Energy Meter with Bypassing arrangement.

The seizure list is prepared at the site and the accused person signed in the seizer list

The inspection team left the above premises at about 02:15 PM on dated 19/03/2020 The accused person has committed an offence U/S-135(i)(B) of the Electricity (Amendment) Act-2007.
