


- 2. That the father of the complainant during his life time purchased the piece of land at Kantadih beside 32 N.H. in the nameof his elder brother Subodh Chandra Kundu to establish shop rooms for Subodh Chandra Kundu and the petitioner. The R.S. plot No. of which is 1812/1840.
- 3. That thereafter Subodh Chandra Kundu established two shop rooms and the complainant raised one shop room for him over the said land and in the said shop room the complainant used to run a bi-cycle repairing shop since last 20 years.
- Kundu used to claim ownership over the entire land on the plea that the title died in question is in the name of him and pressurised the complainant to leave and vacate the said shop room but as the complainant did not vacate the same Subodh Ch. Kundu in the year of 2013 filed title suit No. 78/2013 against the complainant before the Ld. Civil Judge (Senior Divn.) Purulia praying for recovery of possession by evicting the complainant from his his shop room but subsequently with the intervention of the other brothers and sisters of them Subodh Ch. Kundu admitted the right ax the complainant and withdrawn the said suit.

sold and transferred the entire gland to Manik Ch. Mandal and Abedin Ansary.

- when same to know about the fact then also admitted the right of the complainant and never disturbed/disputed the possession of the complainant over his shop room rather then mounted pressure upon their waskers? Vender Subodh Ch. Kundu to return back 1/3 (one third) of consideration for the portion of the complainant.
- 7. That thereafter there was no dispute of the complainant with Manik Ch. Mandal and Abedin Ansary but all on a sudden from some day of November 2019 the accused persons above-named started giving him ultimatum to leave and vacate shop room at his own otherwise they shall disposses him by demolishing the shop room in question, but the complainant tried his best to make them understand.
- 8. That meanwhile on 26/11/2019 at morning when the complainant went to his shop room to open the same then he found his shop room was in ruined completely and all the machinaries and new parts of cycle valued at least of Rs. 40,000/- taken away better to say theft by the accused persons which he came to know from the operator of J.C.B. Machine which was standing beside the road.
