Sir,

In producing herewith arrested accused person namely Dukhu Mura (35 Yrs), S/O-Lt-Kamalakanta Mura of Vill-Bareria, PS-Baghmundi, Dist Purulia along with seized articles,

I beg to report that on 06.03.2020 in between 18:30 hrs to 19:00 hrs in course of Mobile Duty I SI Sudhir Kumar Mahato of Bagmundi PS received telephonic information from my source over telephone that huge numbers of chullu in a Jeri can are staged in the house of Dukhu Mura (35 Yrs), S/O-Lt-Kamalakanta Mura of Vill-Bareria, PS-Baghmundi, Dist Purulia. The above noted person is selling chullu in his respective house, accordingly I informed to my O/C Baghmundi PS in this regard. As per direction of O/C Baghmundi PS myself along with force reached at Bareria village at the house of above noted person to work out the information. Myself along with force reached the spot and held raid in the house of above noted person and found that the some persons were assembled and consuming liquor inside the house of the above noted person.

On seeing police party the assembled persons managed to flee away from the spot. On search there and found that the said person has selling chullu in his house premises. On demand he failed to produce any valid papers/ documents in support of selling chullu in his respective house and I seized 1) 10 (Ten) liters chullu in white plastic Jeri cane, 2) 08 (Eight) liters chullu in white plastic Jeri cane 3) 03 (Three) pcs steel glass, 4) Cash Rs. 110/- (One hundred Ten only) as sale proceed, from the possession of above noted person under proper seizer list duly signed by him and witnesses also prepared label. Accordingly I arrested him after maintaining all arrest rules as well as guideline of NHRC.

Therefore I pray before you that kindly arrange to start a specific case as per law against arrested accused person Dukhu Mura (35 Yrs), S/O-Lt-Kamalakanta Mura of Vill-Bareria, PS-Baghmundi, Dist Purulia and arrange for its investigation.
