I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Prashanta Rajak, S/O- Sri Ram Ratan Rajak of village Birgram (Nichpara), P.O- Birgram PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 17/03/2020 at about 1:05 P.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundi CCC along with 1. Gurpratap Singh, HGTSH 2. Sri Prabir Adhikary, OSH entered the premises of Sri Prashanta Rajak, S/O- Sri Ram Ratan Rajak of village Birgram, P.O- Birgram, Dist- Purulia and found Sri Prashanta Rajak was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.10 KVA. As Sri Prashanta Rajak S/O- Sri Ram Ratan Rajak committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Gurpratap Singh, HGTSH 2. Sri Prabir Adhikary, OSH. The inspection team left the premises at 1:15 P.m.
