Sub: Complaint against Rajib Tudu (25 Yrs), S/O- Sarat Chandra Tudu of Vill- Ukamgarh PO-Sindraidih PS - Boro, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. person Rajib Tudu (25 Yrs), S/O- Sarat Chandra Tudu of Vill- Ukamgarh PO- Sindraidih PS - Boro, Dist - Purulia with seizure of approx 20 liters illicit spirit, containing in 02 (Two) ten liters white Zariken from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that today (02.03.2020) during my evening mobile duty in between 18:45 hrs & 19:15 hrs acting on secret source information I apprehended the above noted person at Ukamgarh at his Grocery Shop and found that above noted ID Liquor which was kept in his Grocery Shop. On interrogation he disclosed his name and address as noted above. On demand he failed to produced any valid documents / License in r/o said illicit spirit which were kept in his Grocery Shop containing approx 20 ltrs illicit spirit, in 02 (Two) ten liters white Zariken. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 19:15 hrs u/s 67 B.E. Act and during arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 1000 ml taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Rajib Tudu (25 Yrs), S/O- Sarat Chandra Tudu of Vill- Ukamgarh PO- Sindraidih PS - Boro, Dist - Purulia violate section 18(i) B.E. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention and he committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) C/678 Ramprasad Paine, (2) C/ 682 Mansaram Rajak accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Rajib Tudu (25 Yrs), S/O- Sarat Chandra Tudu of Vill- Ukamgarh PO- Sindraidih PS -Boro, Dist - Purulia.
