Sir,

I, SI Dhirendranath Mandal, Sub-Inspr. of Police, DEB, Purulia, do here by lodge complaint being produced the following seized articles (i) 15 (Fifteen) Nos. of domestic LPG cylinders fully loaded gas in sealed condition of INDANE company (ii) 13 (thirteen) Nos of Empty. Domestic LPG cylinders (iii) 04 (Four) Nos of LPG Cylinders of 05 Kgs in fully loaded gas of INDANE company. And 01 (One) No. of of Empty cylinder of 05 Kgs. to the effect that today on 03.03.2020 on the basis of secret and credible information being directed by Dy. S.P. DEB Purulia I, along with ASI Swapan Chakraborty and HG/1427 Benimadhab Char had been to Boro PS and submitted one requisition to O/C Boro PS for rendering assistance for holding raid at Dangardih under Boro P.S. to work out the received information. Noted the information at Boro PS, vide Boro PS GDE No. 80 dtd.03.03.12020 at 12:35 hrs. Thereafter we along with officer and force of Boro PS left for Dangardih More under this P.S. to work out the information. On arrival at Dangardih More about 12:55 hrs, I talked with local people for help to work out the credible information also for holding raid, search and seizure in the house of one Bijoy Mahato S/o Lt. Adhir Mahato of Dangardih, PS – Boro, Dist.- Purulia. Prior to holding raid I issued notice with an information to co-operate us for necessary search to work out the information. During search, we noticed huge nos. of domestic LPG cylinders were staged inside in a small room beside the house of Sri Bijoy Mahato S/o Lt. Adhir Mahato of Dangardih, P.S. Boro, Dist- Purulia. Due to absence of the above alleged on asking to his wife Smt. Chhabi Mahato it could be learnt that those were staged for selling to the common people in the locality in a high price with a view to earn money.

In absence of Bijoy Mahato to asking his wife Smt. Chhabi Mahato failed to produce any valid documents or any satisfactory account in support of stock of LPG cylinders as well as possession of those cylinders and for such illegal business. Hence, held raid accompanied with officers and force with proper co-operation of his wife and local people. Accordingly I seized the above 33 no's of gas cylinders (Big and Small with loaded and Empty) under proper seizure list in presence of local people and his wife, from inside the small room of the above accused Bijoy Mahato in between 13:35 hrs and 14:15 hrs.

In course of local enquiry it revealed that said Bijoy Mahato is running such clandestine business of LPG Gas Cylinder since long without having any authority or license, only for causing wrongful gain for causing loss of revenue to the Govt. violating the security measures and law as well as depriving the local consumers / customers. As such he violated the provisions laid down in the rule 3 of West Bengal Cooking Gas (Licensing & Control order) 1985. Hence he comes under the purview of E.C. Act and has committed offence punishable u/s 7(i)(a)(ii) of E.C.Act' 1955.

I therefore pray, before you to start a case under proper section of law against accused Bijoy Mahato S/o Lt. Adhir Mahato of Dangardih, PS – Boro, Dist.- Purulia.

As per order of Dy. SP (DEB), Purulia SI Sajal Mishra of DEB, Purulia will investigate the case.
