Sir,

In producing herewith aced Jitendranath Mahato @ Jiten Mahato(28years) S/O- Suchand Mahato of Vill- Ankro Tola Kuldih, P.S Boro, Dist-Purulia with one improvised country made Pipe gun and one round of live ammution, I SI Gopal Bhattacharyya beg to state that in course of evening mobile duty at Kutni side received a secret source information that one person was seen moving suspiciously near Telikocha more.

Receiving such information myself along with other force left for Telikocha more at about 19:45 hrs .We reached A little far from there and reached to him by waking in hiding and as per identification of my source myself along with force apprehended the said person. Being asked he disclosed his identity as above. On search (1) **an improvised country made Pipe gun having butt 09 CM approx, and barrel 14 CM approx in length total length 26 CM, having trigger and firing pin, recovered from the back side of his waist** (2) **One round of live ammution of .303 found in his left pocket of pant.** On demand he was unable to produce any valid documents /license in respect of keeping such arms & ammution, neither he can gave any satisfactory explanation in respect of carrying such arms ammution. It appeared he possessed those either to sell or to commit any crime. So I seized the said arms and ammution under proper seizure list and labeled in presence of police witnesses since none found there available to witness the seizure in between 20:05 hrs and 20:45 hrs. Hence I arrested him at 21:05 hrs as he has committed an offence which is punishable U/S – 25/27 of Arms Act.

Hence I pray to start specific case against aced Jitendranath Mahato @ Jiten Mahato S/O- Suchand Mahato of Vill- Ankro Tola Kuldih, P.S Boro, Dist-Purulia under proper sections of Arms Act.
