To The Officer- In-Charge Hura Police Station Dist-Purulia.

Sir,

In producing herewith one arrested accd. Person namely Mathur Bauri 58 years S/O Lt Baul Bouri of Vill- Punchadih, PS- Hura Dist.- Purulia brought under arrest with seized articles, 34(thirty four) sealed bottles of country spirit (DIL KHUSH) containing 600 ml each loaded with one white coloured plastic bag. I do hereby lodged this written complaint to the effect that on-06/03/2020 at about 18:25 hours when I and along with my force performing evening mobile duty at near Gurda More I received an information from my reliable source that one person was selling and stocking country spirit illegally in a hues quantity at Punchadi village. I informed the information to O/C Hura PS for onward transmission and as per direction of him I along with my accompanying force rushed to the spot to work out the information and held raid. We the police party found the above noted person was stocking one plastic bag loaded with country spirit in his house. Seeing police party he started to flew away after a small chase we were able to detain one person who on asking disclosed his identity as noted above. On search we found 34(thirty four) sealed bottles of country spirit (DIL KHUSH) containing 600 ml in each bottle. On Interrogation he stated that he use to sale the said country spirit to the local villagers in lieu of money for his illegal gain. On demand he also failed to produce any valid challan / Papers in respect of county spirit. Hence he violated the provision of 46 (A) (c) of B.E. Act.

Accordingly I seized 34(thirty four) sealed bottles of country spirit (DIL KHUSH) containing 600 ml each containing with one white coloured plastic bag from his possession after preparing proper seizure list duly signed by the accd. Person and witnesses and prepared proper label for all seized articles duly signed by the accd. Person and witnesses in which one bottle labled for sample. I search for local public witnesses but found none. Then I arrested accd. namely Mathur Bauri 58 yers S/O Lt Baul Bouri of Vill- Punchadih PS- Hura

Dist.- Purulia and prepared arrest memo.

I return to P.S. along with accd person and all seized articles. Put the accd. Person in the Lock UP after maintaining all formalities and submitted this written complain before you to start a case against Mathur Bauri 58 years S/O Lt Baul Bouri of Vill- Punchadih PS- Hura Dist.- Purulia under proper section of law.
