Sir,

In producing here with the following arrested accused persons namely (i) Radhanath Kuiry (45 yrs) S/O Lt. Prabhudas Kuiry of Jhalda Wadrd No-03, PS- Jhalda, Dist- Purulia, (ii) Samir Nayek (21 yrs) S/O Bistu Nayek of Vill- Gokulnagar, PO-Mosina, P.S. Jhalda, Dist. Purulia, along with 02[two] seized Tractors- (i)WB55B/1301, (ii) WB55A/7357, all are attached with a sand loaded trolley, the fact in brief is that today(14.03.2020) evening at about 16:35 hrs received a credible source information that few tractors was carrying sand illegally and coming from Tulin ghat & going towards Jhalda side. Accordingly, myself along with force left PS to work out the said source information. This refers to Jhalda PS GDE No- 536 Dated- 14/03/2020 & Jhalda PS CC No- 825 Dated- 14/03/2020. Then, we intercept the said vehicles near Mosina village (Purulia Ranchi road) under Jhalda PS at about 17:25 hrs and found the above noted tractors were tagged with a trolley each being loaded with sand. On asked, the drivers disclosed their identity as mentioned earlier. On demand, all of them failed to produce any valid papers in respect of the Tractors which are attached with a Trolley as well as loaded sand though sufficient time was given. During interrogation, the drivers of the said tractors confessed that they in convince with the respective owners of said seized Tractors & others. Then, I SI Bikash Ch. Patra arrested the following accused drivers of said vehicles (as disclosed during interrogation)- (i) Radhanath Kuiry (driver of the tractor Mahindra WB55B/1301 S/O Lt. Prabhudas Kuiry of Jhalda Wadrd No-03, PS- Jhalda, Dist- Purulia, (ii) Samir Nayek (driver of the tractor WB55A/7357 S/O Bistu Nayek of Vill- Gokulnagar, PO-Mosina, P.S. Jhalda, Dist- Purulia under proper arrest memo and also seized the Tractors- (i)WB55B/1301, (ii) WB55A/7357 with attached sand loaded Trolley(approx 100 cft) each.

On return to P.S., Put the arrested accused persons into the P.S. Lock UP after maintaining all formalities, kept the sand loaded seized vehicles at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Radhanath Kuiry (45 yrs) S/O Lt. Prabhudas Kuiry of Jhalda Wadrd No-03, PS- Jhalda, Dist- Purulia, (ii) Samir Nayek (21 yrs) S/O Bistu Nayek of Vill- Gokulnagar, PO-Mosina, P.S. Jhalda, Dist. Purulia (iii) Owner of the Tractor WB55B/1301, (iv) Owner of the Tractor WB55A/7357 & others under proper section of law.
