I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Gobinda Bouri, S/O-Lt Agnu Bouri of village-Kokiara, P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 16.03.2020 at about 1.10 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato Gr1 TSH, Joypur CCC 02.Shibaram Mahato, HG TSH, Joypur CCC, entered the premises of Gobinda Bouri, S/O-Lt Agnu Bouri of village- Kokiara, P.S- Joypur, Dist- Purulia and found Gobinda Bouri, S/O-Lt Agnu Bouri was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through plastic Cu cable Blue colour by means direct hooking to his house premises and connected load found 0.521 KW. As Gobinda Bouri, S/O-Lt Agnu Bouri committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato Gr1 TSH, Joypur CCC 02. Shibaram Mahato, HG TSH, Joypur CCC. The inspection team left the premises at
