I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Murulidhar Mahato, S/O-Lat Kinu Mahato of village-Shyampur, P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 135(i) (b) of electricity act 2003 subsequently amendment act 2007.

On 16.03.2020 at about 2.50 P.M . I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with D1.Ganesh Mahato Gr1 TSH,Joypur CCC 02.Shibaram Mahato.HG TSH,Joypur CCC, entered the premises of Murulidhar Mahato, S/O-Lat Kinu Mahato of village- Shyampur, P.S- Joypur , Dist- Purulia and found that Murulidhar Mahato, S/O-Lat Kinu Mahato was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through plastic Cu cable Black colour by means Meter Bypass to his house premises and connected load found 0.42 KW. As that Murulidhar Mahato, S/O-Lat Kinu Mahato committed theft of electric power.So, I seized the following articles after preparing the seizer list in presence of D1.Ganesh Mahato Gr1 TSH,Joypur CCC 02. Shibaram Mahato,HG TSH,Joypur CCC. The inspection team left the premises at 3.00 P.M.
