Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Basanta Das S/O Lt Radhanath Das, Vill- Layekdih, PO -Manihara Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 19.03.2020 at about 2.10 pm during periodically inspection myself along with DE,S&LP Wing of Regional Office and Sri Dipak Kr. Bhowmik, SAE,Kashipur CCC and Sri Sanjoy Garain, OE Kashipur CCC was visited the premises of Sri Basanta Das S/O Lt Radhanath Das, Vill- Layekdih, PO -Manihara Dist-PURULIA. During inspection it has been found that Sri Basanta Das S/o Lt Radhanath Das is consuming electricity dishonestly by means of plugging a cut piece of wire and inserted the same from incoming point to outgoing point of phase wire to bypassing the actual registration of consumption on his premises . During investigation they could not clarify for such type of activity as it is a type of theft.

After that we disconnect his permanent service line bearing con id 242245195 and seized the meter fitted with small portion of service cable and a small piece of wire(use for theft),Meter no 1026029 make-Genius .

Total Load found approx 0.48KW (Fridge 01 nos, TV-02 nos, CFL-3 nos, Fan -02 nos)

After preparation of proper seizure list The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 02.30 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
