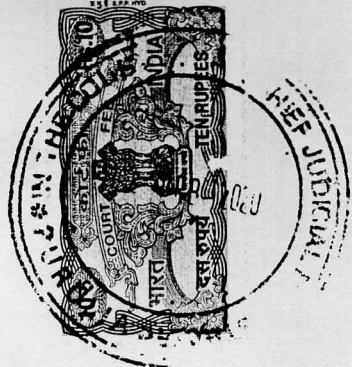

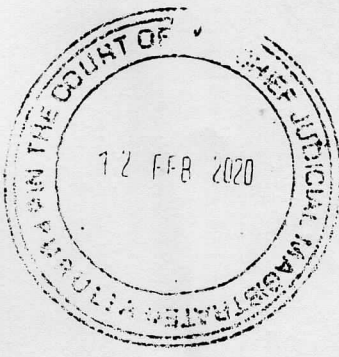

begs to state as follows :-

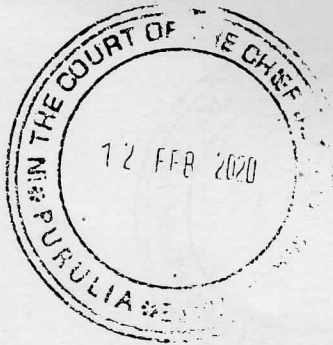
1...That the complainant and the accused persons are the residents of the same village Pirrah under Kenda P.S.

2...That the land fully described in the schedule below belonged to and was in possession of Mangobind Sing Patar, father of the complainant. As per right, title and possession the schedule below land has been recorded in the name of Mangobinda Sing Patar in the record of right.

3...That after the death of Mangobinda Sing Patar, the father of the complainant, the complainant is possessing the schedule land exclusively, continuously and peacefully. The complainant has developed the schedule land considerably by physical labour and also my manuers etc. and planted Sonajuri trees over the schedule land which in due course was fully grown up and developed.

4...That the accd. persons are influence persons in the locality. They have ill eyes over the developed trees of the complainant and threatened the complainant to cut away the said trees on showing various pretexts.

5....That on the date of occurrence at about 11 P.M. the accused persons being variously armed criminally trespassed the schedule land and they cut and took away

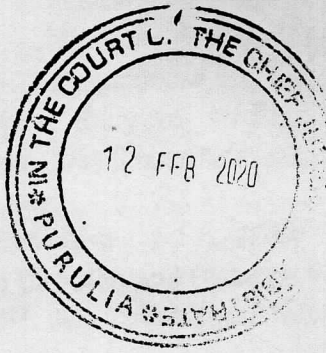

took away 5 (five) Sonajuri trees from the schedule land.

Being informed the complainant rushed to the schedule land and found that the accused persons have taken away the cut wood from the said land and he began to search for the same and on the following <sup>day</sup> in the evening he found that the accused persons brought the said wood after splitting the same by a tractor. The complainant restrained the said tractor and asked the accused from where they brought the wood. The accused persons hurriedly unloaded the split wood and fled away. Thereafter the complainant kept the said wood in jimma to the village-panch and reported the matter to the Police. The Police told him that they will to very soon for enquiry but the Police neither came nor took any action against the accused persons, then the complainant informed the matter to S.P. Purulia on 2.12.19 but of no good.

6...That the trees which has cut down and taken away by the accused persons would valued Rs. 20,000/- (Rupees twenty thousand). So the accused persons have committed several offences and they are liable to be punished for the same.

7... That the complainant is a poor man and he is not in a position to conduct the case by his own means. Moreover there are certain technicalities involved in this case which cannot be done in a complaint oriented Case.


