Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Haru Bauri, S/O Hasu Bauri of Village- Bansole Gobindapur, P.O- Bishri, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(b) of the Electricity (Amendment) Act-2007.

It is mention that service connection effected against Haru Bauri, S/O Hasu Bauri (having consumer ID -242307881, Meter No DDG253771)

On dated 17.03.2020 at about 11:45 AM I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

- 1) Sri Mrityunjay Mandal, J.E. Gr.-I (E), Manbazar CCC
- 2) Sri Shyamal Rajak, HG. TSH, Manbazar CCC

entered the premises of Haru Bauri, S/O Hasu Bauri of Village- Bansole Gobindapur, P.O- Bishri, P.S.- Manbazar, Dist - Purulia and inspected his premises and found that he was enjoying electricity un-authorisely i.e bypassing of energy meter from incoming terminal point.

During inspection, theft of electricity was found, i.e., he was using electricity dishonestly U/S 135(1)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and two piece of wire by which electrically directly flow to his house without energy registration in WBSEDCL energy meter. It was also found that he was using the following electrical equipments -

- 1) One no 60 Watt Fan
- 2) One no 100 watt bulb
- 3) Two no 7 watt LED bulb
- 4) One no 60 Watt TV

out of which we seized the following -

- 1) One no 7 Watt LED bulb
- 2) Two mtr flexible (two) wire

3)

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 12:05 PM on dated 17.03.2020. The accused person has committed an offence U/S 135(1)(b) of the Electricity Act 2003, subsequently Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
