I SI Bablu Ghosh of Neturia P.S. Dist Purulia do hereby submit a written complaint against some unknown persons to the effect that today at about 10.05 hrs received an information that some unknown persons assembled at Puapur near the gate of Garh Panchakot Eco-Tourism Resort and raised agitation against Hotel owner and workers with a view to stop Hotel immediately over the different local issues. Accordingly I conveyed misinformation to OC Neturia PS and as per order of O/C Neturia PS I along with force left for the anticipated place to work out the information, which refers to Neturia P.S. GDE No. 1024 date 22.3.2020. On reaching at spot at about 11.00 hrs I found that approx 100/150 unknown persons assembled forming as unlawful assembly on Puapur- Gobag Road near the gate of Garh Panchakot Eco- Tourism Resort at Puapur under Neturia PS continued shouted to stop the Hotel immediately over the different local issues and they were started pelting stones/bricks bats towards said hotel as a result some advertisement posters and window of Resort partly damaged. Again during local enquiry it was also learnt that before reaching police at the spot a hot altercation was took place in between workers of the said Resort and local villagers over the different local issues and both parties threatened to each other and also quarrel took place and assaulted as a result 4/5 persons received injuries on their persons and sifted to Hospital for treatment. I requested the agitators to stop such type of activities and left the place but they continued to be with the unlawful assembly with ulterior motive and in furtherance of their common intension. Informed the matter to OC and after some time OC Neturia PS, CI, Raghunathpur and SDPO Raghunathpur reached at spot and after discussion the mob left the place. After returning PS I submitted complaint against 100/150 unknown persons of Puapur village, PS- Neturia, Dist- Purulia and 10/12 worker of Garh Panchakot Eco-Tourism Resort Village -Puapur, PS- Neturia, Dist- Purulia to start a specific case under proper section of law.
