
Sub: Incidence of forgery and unauthorized usage of Government Letterhead. Logo & Seal

Sir

Recently from hearsay and various sources it has been brought to our notice that some people are issuing forged appointment letters and other documents imitating the letterhead of our Medical College and Hospital and are making fake promises of providing a job in this institution. Such an incident was brought to our notice yesterday when one Rukshana Bibi(Mobile No: 9641498958) complained to me that a person named Subodh Bauri who is a resident of Rail Quarter, Locoshed para, Purulia(Mobile No.: 7001198321) had allegedly got an appointment letter issued (as annexed) which has the Government Logo & Seal, making a fake promise of a job and has already taken a tertain amount from her in that context. However, on confirming from our department & office it was found that neither such recruitment notification has been released nor an appointment letter was issued as described.

We would like to draw your kind attention in this regard and would request you to kindly conduct necessary nvestigations and provide a solution to the matter and restrict such incidences in future.
