Sir,

In producing herewith one Hemanta Sardar (21yrs) S/O Dhananjay Sardar of Vill-Rampur, PS-Purulia (M), Dist-Purulia along with seized vehicle (Tractor) bearing WB55B 0997 attached with Trolley loaded with sand seized under proper seizure list and memo of arrest in respect of the supra person before you.

The nub of the fact in a nutshell is that today 08.03.2020 at 13:40 hrs while I along with force namely 1) C/253 Aurobindo Mallik 2) C/223 Jiban Kumar Mahanti 3) C/39 Jaharlal Sanyal left the PS for performing mobile duty vide CC No 684/20 Dated 08.03.20 and Purulia (M) PS GDE no 372 Dated 08.03.2020 in PS area. During my mobile duty, I received a tip off at 14: 15 hrs that a suspicious tractor loaded with sand was coming from kotlui village towards Bhatbanh, Purulia. Subsequently, I along with force proceeded towards Kotlui village to work out the tip off. While I along with force arrived near Anandamath Home and found that one tractor was coming from Simulia side. I along with force intercepted the vehicle (Tractor) bearing WB55B 0997 attached with Trolley loaded with sand after placing the guardrail on the road at 15:05 hrs and found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the said vehicle disclosed his name noted in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious one to us. It was ascertained that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Kansaboti river at Kotlui side by fraudulently means or theft by any means for transporting the same to run clandestine business So I, seized the tractor bearing WB55B 0997 attached with Trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Hemanta Sardar (21yrs) S/O Dhananjay Sardar Vill- Rampur, PS- Purulia (M), Dist-Purulia after informing the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said tractor to Purulia (M) P.S.

Under the above facts and circumstances kindly take lawful action against the driver namely, Hemanta Sardar (21yrs) S/O Dhananjay Sardar Vill- Rampur, PS-Purulia (M), Dist- Purulia and the owner of the vehicle as the committed offence U/S 379/411/414/120B of the IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.
