Sir,

In producing herewith seized vehicle (Lorry) bearing Registration No JH 05CK 0848 and 04 (four) numbers of Guard rail seized under proper seizure list before you.

The nub of the fact in a nutshell is that today 09.03.2020 at 16:45 hrs while I SI Nabin Chandra Ojha along with force namely 1) C/596 Subhasis Panda 2) C/ 254 Karunamoy Bauri left the PS for performing mobile duty vide CC No 967/20 Dated 09.03.20 and Purulia (M) PS GDE no 419 Dated 09.03.2020 along Purulia Ranchi Road and to perform Naka Checking at Imundih More near Pandey Hotel Under Purulia (M) PS. During my Naka Checking duty at 19: 55 hrs, I gave the signal to the vehicle (Lorry) bearing Registration No JH 05CK 0848 and placed the guard rail after keeping a safe distance but the driver of the vehicle was driving so rash and negligently and violated my signal and dashed the guard rail though I along with force saved ourselves and chased the vehicle accordingly. Thereafter the said vehicle dashed at about 20:05 hrs good number of motor cycles which were parked near Moti Hotel beside the Purulia – Ranchi Road (NH-32) though the some public who stood beside the road saved themselves. Subsequently, the vehicle was ceased beside the road. I along with force arrived at Moti Hotel at 20:15 hrs and found that the vehicle was ceased transversely beside the road and no one in the vehicle. I searched for the driver of the vehicle but none stood before me as the driver of the vehicle. As per the local enquiry it revealed that after dashing those motor cycles the vehicle was ceased. While the local residents chased and created hue and cry, the driver of the vehicle fled away leaving the vehicle. During the endemic enquiry, the eye witness of the incident stated before me that the driver of the vehicle was driving rash and negligently which endangered the human life. Consequently, I seized the offending vehicle in presence of the witnesses duly signed by them. After arranging a local driver, I brought the offending vehicle to PS and submitted the complaint against the driver of the vehicle (Lorry) bearing Registration No JH 05CK 0848 as he committed offence U/S 279/427 of the IPC and 3 of the Prevention of Damage to Public Property Act, 1984.

Therefore, I pray before your good self that a specific case may kindly be started against the driver of the vehicle (Lorry) bearing Registration No JH 05CK 0848.
