Respected Sir,

In producing herewith the driver namely Tarapada Sing Sardar (27 yrs) s/o Lt. Sakti @ Sasti Sing Sardar of Vill- Bajra, PS- Barabazar, Dist- Purulia & caretaker cum manager namely Ojha Sing Sardar (23 yrs) s/o Mongal Sing Sardar of Vill- Rampur, PS- Purulia (M), Dist- Purulia along with seized vehicle (Tractor) bearing Reg. No WB55A-9278 attached with seizure list, memo of arrest and inspection memo in respect of the supra persons before you.

The nub of the fact in a nutshell is that on 13.03.2020 at 15:45 hrs while I along with force 1) C/111 Samulal Tudu, ii) C/778 Sanjoy Chowdhury & iii) JC/1377 Rahul Islam Ansary all of Tamna O.P. under Purulia (M) PS left the Tamna Out Post for performing evening mobile duty vide Tamna O.P. CC No 260/20 and GDE No 368 Dt. 13.03.2020 in Tamna O.P. area. During my evening mobile duty, I received a tip off at 21:05 hrs that a suspicious tractor loaded with sand was coming from Rampur village towards Tamna More. Subsequently, I along with force proceeded towards Rampur village to work out the tip off. While I along with force arrived near Borakdih village more and found that one tractor was proceeding towards Tamna More along Arsha Road. I along with force intercepted the vehicle (Tractor) bearing Reg. No WB55A-9278 attached with Trolley loaded with sand after placing the guardrail on the road at 21:25 hrs and found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver and one another person (caretaker) of the said vehicle disclosed their name noted in the supra. I asked the driver and caretaker cum manager of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver and caretaker cum manager of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver and caretaker cum manager to produce the valid paper but they stated differently in different times. The incoherent statement of the driver & caretaker cum manager purported to be a suspicious one to us. It was ascertained that the driver and caretaker cum manager of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that they in cahoots with the owner of the vehicle procured the said sand from Kansai River near Rampur village side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the tractor bearing Reg. No WB55A-9278 attached with Trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver and caretaker cum manager namely i) Tarapada Sing Sardar (27 yrs) s/o Lt. Sakti @ Sasti Sing Sardar of Vill- Bajra, PS- Barabazar, Dist- Purulia & ii) Ojha Sing Sardar (23 yrs) s/o Mongal Sing Sardar of Vill- Rampur, PS- Purulia (M), Dist- Purulia after informing the ground of their arrest and issued Memo of Arrest against them. Thereafter, I brought the said seized tractor to Tamna O.P. under Purulia (M) PS.

Under the above facts and circumstances kindly take lawful action against the driver & caretaker cum manager namely i) Tarapada Sing Sardar (27 yrs) s/o Lt. Sakti @ Sasti Sing Sardar of Vill- Bajra, PS- Barabazar, Dist- Purulia & ii) Ojha Sing Sardar (23 yrs) s/o Mongal Sing Sardar of Vill- Rampur, PS- Purulia (M), Dist- Purulia and the owner of the vehicle as the committed offence u/s 379/411/414/120B of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-1995.
