Service connection of Asgar Ansary, S/O Lt Nur Mohammad, Chargali, PS - Purulia (M) bearing ID no 201703169 was disconnected on 17.03.2020 due to nonpayment of electric bill Rs3525.00. On 18.03.2020 consumer paid bill amount Rs3500.00 and disconnection reconnection charge Rs100.00. Rahul Traders, one enlisted vendor of WBSEDCL was entrusted to do the reconnection work. On 19.03.2020 at about 4.00 PM 4 staffs of Rahul traders 1) Jahangir Ansary, Kasai mahalla, Purulia 2) SK Rahul, Kasai Mahalla, Purulia 3) Bibek Mahato, Anai 4) Santu Mahato, Anai went to reconnect the service connection. Upon reaching to the premises Asgar Ansary, S/O Lt Nur Mohammad, vill - Chargali abused them with filthy language, physically assaulted and threatened not to disconnect further in any condition. Here it may be mentioned this consumer is a habituated defaulter and every time our staffs go to his house for realization of outstanding dues he misbehaves with them. In such condition all staffs associated with field job are feeling insecure and demoralized.

Therefore you are requested to investigate this matter and take appropriate measure against the miscreant.

This complaint may be treated as FIR.
