and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing
the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage
installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his
house without energy registration in WBS EDC L energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Fan - 02 nos.
- 2) Tube light - 02 nos.
- 3) Heater - 01 no.
- 4) Color TV - 01 no.

Out of which I seized the following.

- 1) By passing arrangement alongwith Meter vide Meter No - B2375059.
- 2) Electric Heater alongwith wire - 01 no.

Seizure list was prepared at the site and accused person refuse to sign/signer ^{or Consumer}. The inspection team left
the premises at 2:15 PM on 03/03/20. The accused person has committed an offence
