I am to inform you that one person namely Sk. Sukur S/O Sk. Peso of Village Hutmura, PS. Purulia(M) came on 07.03.2020 at about 11.15 A.M beside outside perimeter wall No. 05. and threw a new Mobile cell phone with a battery and charger inside the Correctional Home with a target to give it to UTP Sk. Niyamat @ Mongla who lodged in this Correctional Home. The Cell phone bearing model No H7 (HEEMAX) was recovered from Sk. Niyamat @ Mongla. Sri Asish Ghosh, Controller and DEO Tufan Maity of Purulia Spl. Correctional Home identified Sk. Sukur who threw the Cell phone inside the Correctional Home. Accordingly, I informed Purulia Town Police Station over Telephone. It is mentioned that the offence is cognizable and be triable by the court of the Magistrate of 1st class under Amendment of section 2 of West Ben. Act.
