In producing herewith 04 (four) arrested accused persons namely (1) Gourav Kumar Tiwary (27 yrs) s/o Birendra Sir, Kumar Tiwary of BSI.LH, Street no- 12, Quarter no- 10, PS- B.S. City, Dist- Bokaro, State- Jharkhand, (2) Sonu Kumar Singh (22 yrs) s/o Maladhar Singh of Joshy Colony, Lakra Khada, Bokaro Steel City, PS- B.S.City, Dist- Bokaro, State-Jharkhand, (3) Pintu Kumar Yadav (28 yrs) s/o Arjun Kumar Yadav of Daibhiga, PO- Hasapur, PS- Narhat, Dist- Nabada, State-Bihar, (4) Sk. Affan (32 yrs) s/o Sk. Bakkar of Vill-Hutmura, PS-Purulia (M), Dist-Purulia, with following seized articles (1) One crowbar length 02 ft approx (2) One red colour Nylon rope about 25 ft length (3) 02 Khukri (Katari) 14" and 12" approx (4) one black colour small torch (5) One Iron Rod length approx 03 ft (6) One foldable knife, that on 09.03.2020 at 23:45 hrs in course of my night mobile duty (vide Purulia (T) PS GDE No-525 dt 09.03.2020) I received secret information from a source that a gang of criminals comprising of 10/11 heads under the leadership of (1) Gourav Kumar Tiwary (27 yrs) s/o Birendra Kumar Tiwary of BSLLH, Street no- 12, Quarter no- 10, PS- B.S. City, Dist- Bokaro, State- Jharkhand, being armed with deadly weapons etc with a view to commit dacoity at Lila Petrol pump beside

Accordingly I informed the matter to O/C Purulia (T) PS, over RT and contacted with all night patrolling officers, B.T.Sarkar road, Purulia. briefing to all. I immediately along with source and ASI Barun Kumar Das, C/818 Swapan Das, HG/1454 Prakash Char, C/326 Tapan Saha and C/1234 Mantulal Mandal, left to work out the information with Govt. vehicle No WB 56C 0800. At 23:45 hrs we reached at Jail Bagan near Borohat, Purulia, the place where the accused were assembled and preparing themselves for committing dacoity. From a distance of about 40 yards we cordoned them. Their whispering came to our knowledge regarding committing of dacoity in the houses at Lilha Petrol pump beside B.T.Sarkar Road, Purulia. We crawled nearer to them and disclose our identity and asked them to surrender; at that time, they all started to fled away, we chased them by using dragon light device. After a hot chase we could able to apprehend (1) Gourav Kumar Tiwary (27 yrs) s/o Birendra Kumar Tiwary of BSLLH, Street no- 12, Quarter no- 10, PS- B.S. City, Dist- Bokaro, State- Jharkhand, (2) Sonu Kumar Singh (22 yrs) s/o Maladhar Singh of Joshy Colony, Lakra Khada, Bokaro Steel City, PS- B.S.City, Dist-Bokaro, State- Jharkhand, (3) Pintu Kumar Yadav (28 yrs) s/o Arju Kumar Yadav of Daibhiga, PO- Hasapur, PS- Narhat, Dist- Nabada, State- Bihar, (4) Sk. Affan (32 yrs) s/o Sk. Bakkar of Vill- Hutmura, PS-Purulia (M), Dist-Purulia, as identified on interrogation. On further interrogation they stated that they along with 6/7 unknown other were assembled there and preparing themselves for committing dacoity at the houses at Lila Petrol pump beside B.T.Sarkar road, Purulia. We searched the above persons and following items were recovered from their possession, as (1) One crowbar & Nylon rope about 25 foot length from the possession of Sk. Affan, (2) one foldable knife from the front side jeans pant and one iron rod from right hand of accused Gourav Kumar Tiwary (3) One khukri from right hand and a torch from the left hand of accused of Sonu Kumar (4) One khukri from right hand of accused of Pintu Kumar Yadav 6/7 unknown others, one of them was carrying Fire Arm able to escape. On demand, they failed to give any satisfactory explanation in respect of their presence at that area in the dead hours of night with such deadly weapons. So it is crystal clearly that they were assembled in that area to commit dacoity and thereby they are liable for punishment U/S 399/402 IPC. As such 00:15 hrs to 01:45 hrs on 10.03.2020, the above noted accused persons were arrested maintaining all guidelines of Hon'ble Supreme Court of India and seized the above articles preparing seizure list duly signed by accused persons. As no public witnesses were present at the abandoned area thus seizure list was signed by the accompanied officers and force.

On return to PS, I lodge complainant against (1) Gourav Kumar Tiwary (27 yrs) s/o Birendra Kumar Tiwary of BSLLH, Street no- 12, Quarter no- 10, PS- B.S. City, Dist- Bokaro, State- Jharkhand, (2) Sonu Kumar Singh (22 yrs) s/o Maladhar Singh of Joshy Colony, Lakra Khada, Bokaro Steel City, PS- B.S. City, Dist- Bokaro, State- Jharkhand, (3) Pintu Kumar Yadav (28 yrs) s/o Arjun Kumar Yadav of Daibhiga, PO- Hasapur, PS- Narhat, Dist- Nabada, State- Bihar, (4) Sk. Affan (32 yrs) s/o Sk. Bakkar of Vill- Hutmura, PS-Purulia (M), Dist-Purulia & 6/7 unknown others for starting a case U/S 399/402 IPC and also for arranging for its investigation.
