At around 4 pm on 10<sup>th</sup> March 2020, officials of NCR Corporation India Pvt Ltd have informed us that there have been thefts in following 2 ATM counters of our bank:

- PNB ATM N2047500 - BT Sarker Road, Near Zilla School More, Purulia
- PNB ATM N3047500 - Tata Road ,Near Sunil Petrol Pump, Purulia

The thieves have broken the cash dispenser shutter in both the ATMs and have stolen money from it. The details of cash shortage is as under-

Besides the bank has suffered loss as the damaged parts of the above two machine need to be changed at bank's cost. We already have request our security partner to provide CCTV footage of the incidents and they are already processing our request. The probable time of the crime is any time after 1.54 pm on 05-03-2020.
