Subject: Information regarding embezzlement of Government Money in respect of Recurring Deposit (RD) Account No 88270 by Sk.Lutfunnesha, Garmin Dak Sevak Branch Postmaster (GDS BPM) (Now under Put –Off duty), Nutandih Branch Post Office, Village +P.O- Nutandih, in account with Raghunathpur Sub Post Office, Pin -723133 under Raghunathpur P.S.

Sir,

It is to intimate that the undersigned after getting information from Sub Postmaster, Raghunathpur S.O, regarding discrepancy in few RD A/c balance, made a surprise visit at Nutandih B.O on 20/11/2019 and on further inquiring into the matter with reference to Branch Post Office records i.e BO RD Journal and BO Summary of Raghunathpur S.O and Ledger card of Raghunathpur S.O and other relevant records, on 21/11/2019 it was detected that Sk. Lutfunnesha, GDSBPM, Nutandih B.O, W/o Sk. Haidar Ali, Village+ Post- Nutandih, under Raghunathpur -723133, has committed fraud in RD Account and was immediately placed under Put off duty on 21/11/2019. It is also found that some suspicious /transactions which were made by Sk. Lutfunnesha, W/o Haildar Ali, Village+ P.O- Nutandih, P.S- Raghunathpur, Dist- Purulia, Pin-723133, who was working as Branch Postmaster, Nutandih B.O since 01/03/2001, during her incumbency as Branch Postmaster Branch Post Office under Raghunathpur Sub Post Office.

Considering it as top of the iceberg a thorough Past work verification of the incumbency of said Sk. Lutfunnsesha as Gramin Dak Sevak Branch Post Master, Nutandih Branch Post Office is going on and it has been unearthed that, an amount of about Rs 76,500/- (Seventy Six Thousand Five Hundred Only) has been detected as defalcated in respect of the said RD Account No 88270. The Government money is embezzled by Sk. Lutfunnesha during her incumbency as Gramin Dak Sevak Branch Post Master, Nutandih Branch Post Office. Prima facie.

Details of the defrauded Post Office Recurring Deposit (RD) Account is given below for your perusal and necessary action:-

It is to intimate that in case of above noted RD Account Passbook bearing No 88270, which was opened on 01/11/2014 with Denomination of Rs 1500/- while Sk. Lutfunnesha, was working in the capacity of GDS Branch Postmaster, Nutandih B.O. Since 09/12/2015, Sk. Lutfunnesha used to accept the amount of Deposits from the depositor Sk. Tamjid and made entries for deposit in the depositor's said pass book in her own handwriting with relevant Branch Office seal, put his initials in the said Passbook to authenticate the same but did not deposit the same amounts into the BO Records & BO Daily Account i.e did not credited the deposit amounts to Government account. Consulting Sub Post Office records i.e Sub Office RD Ledger, the above facts is confirmed. Thus defalcated Rs 76500/- in r/o the said RD A/c and used the defalcated money in her personal gain, which she has admitted in her written statement dated 19/03/2020. Sk. Tamjid has also stated the same facts in issue in his written statement dated 19/03/2020.

During the preliminary enquiry, it is learned from native villagers that apart from the misappropriation of Rs.76500/- as noted above it is apprehended that Sk. Lutfunnesha by taking advantage of less educated poor depositor's trust upon the Chair of village Branch Postmaster, used to keep the Customers passbook in her own custody for month after month without any valid reason and assigning proper receipt and thus has misappropriated in other RD and SSA Accounts, standing at Nutandih B.O which will come to light after past work verification is completed and in each such case of misappropriation Sk. Lutfunnesha has used his official position to serve her personal purpose by damaging the trust of valued customers on Department and causing detrimental effects to the image of the Department of Posts.

In view of the above I, Sri Abir Lal Banerjee, S/o Late Gopal Chandra Banerjee, aged-38 yrs, resided at "Lokenath Pally, Kulti College Road, P.O- Kulti, Dist- Paschim Bardhaman, Pin-713343 presently working in the capacity of "Inspector of Posts, Adra Sub Division, Adra", hereby lodge FIR in the capacity of Inspector of Posts, Adra Sub Division and request you to take strict action and arrest the culprit and recover the loss sustained by the Department of Posts, Govt. of India as many more Accounts may be involved in the Fraud.
