Mahato (24 Yrs) S/O Nantu Mahato of Palashkola, near Boro Kali, PS-Adra, Dist- Purulia 3. Bijoy Gorai (25 Yrs) S/O Sunu Gorai of Beko, PS-Adra, Dist- Purulia 4. Rabi Prasad (26 Yrs) S/O Baldeb Prasad of Beniasol, PS-Adra, Dist- Purulia 5. Md. Akram (24 Yrs) S/O Md. Selim of Kamlasthan, PS-Adra, Dist- Purulia 6. Ashok Kr. Mudi (24 Yrs) S/O Abhimunnya Mudi of Kalikend, PS-Adra, Dist- Purulia 7. Debesh Kr. Mudi (28 Yrs) S/O Ajit Kr. Mudi of Kalikend, PS-Adra, Dist- Purulia 8. Kartik Bauri (29 Yrs) S/O Lt. 1. One black Hero Glamour Motor Cycle vide Reg No- WB 82D 1394 from the possession of Santanu Mondal (23 Yrs) S/O Chandidas Mondal of Raghunathpur-Ward No-04, PS-Raghunathpur, Dist- Purulia.
2. One White YAMAHA 15S Motor Cycle vide Reg. No-JH10BL/0419 from the possession of Manoj Kr. Mahato (24 Yrs) S/O Nantu Mahato of Palashkola, near Boro Kali, PS-Adra, Dist- Purulia
3. One Black Hero Glamour Motor Cycle vide Reg No- WB 82A/3284 from the possession of Bijoy Gorai (25 Yrs) S/O Sunu Gorai of Beko, PS-Adra, Dist- Purulia
4. One Black Hero Passion X Pro Motor Cycle vide Reg No- WB 82/2336 from the possession of Md. Akram (24 Yrs) S/O Md. Selim of Kamlasthan, PS-Adra, Dist- Purulia
5. One TVS Jupiter 2X Motor Cycle vide Reg No- WB 82B/9003 from the possession of Ashok Kr. Mudi (24 Yrs) S/O Abhimunnya Mudi of Kalikend, PS-Adra, Dist- Purulia

I SI Manas Kr. Panda of Adra PS do here by lodged' a complaint against above noted 08 accused persons to the effect that on 23.04.2020 at about 10:05 hrs while I was on patrolling duty, found 15-18 persons consist of their 10-12 Motorcycle gathered near Jhankai Seni Kali Mandir. After seeing the police party 06-08 persons consist of their respective 04-05 Motorcycle were fled away. Rest persons also tried to fled away but after reached the spot we managed to detained 05 persons with their Motor Cycles and 03 Pillion rider also. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road or they could not able to give reasonable ground for this gathering. As such the above persons violated the order during this pandemic situation duly promulgated by Ministry of Home Affairs, Govt. of India, vide Order No- 40-3/2020-DM-I (A) dated- 15th April, 2020 to 3rd May 2020. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following 08 (Eight) persons were arrested and seized 05 motor cycles from 11:05 Hrs. to 12:05 Hrs. after maintaining all formalities regarding arrest and seizure and brought them to P.S. I offered them for medical treatment but they denied.

Hence I there for pray that a specific case may kindly be started against above mentioned persons U/S 188/34 IPC & Section 54 in the National Disaster Management Act, 2005.
