In producing here with 06 (Six) arrested accused namely 1. Ravi Yadav (32 Yrs) S/O Chandu Yadav of Kamlasthan, PS-Adra, Dist- Purulia 2.Sital Mukhi (30 Yrs) S/O Jiban Mukhi of Sevanagar, PS-Adra, Dist- Purulia 3.Bablu Karmakar (38 Yrs) S/O Lt. Kamlakanta Karmakar of Kolpara-Palashkola, PS-Adra, Dist- Purulia 4.Dipak Agarwal (45 Yrs) S/O Lt. Serban Agarwal of Kamlasthan, PS-Adra, Dist- Purulia 5.Tarapada Baskey (51 Yrs) S/O Lt. Budhu Baskey of Kantaranguni, PS-Adra, Dist- Purulia 6.Lakhan Majhi (48 Yrs) S/O Lt. Budhan Majhi of Majhidih PS-Adra, Dist- Purulia along with 03 seized Motorcycle with seizure list and Memo of Arrest Following 03 motorcycles seized from the possession of them.

1. Motor Cycle vide Reg No- WB 82C 5459 from the possession of Ravi Yadav (32 Yrs) S/O Chandu Yadav of Kamlasthan, PS-Adra, Dist- Purulia
2. Motor Cycle vide Eng. No-JC73ED0061426 from the possession of Sital Mukhi (30 Yrs) S/O Jiban Mukhi of Sevanagar, PS-Adra, Dist- Purulia
3. Motor Cycle vide Reg No- WB 82A/8303 from the possession of Bablu Karmakar (38 Yrs) S/O Lt. Kamlakanta Karmakar of Kolpara-Palashkola, PS-Adra, Dist- Purulia

I SI Parikshit Mahato of Adra PS do here by lodged a complaint against above noted 06 accused persons to the effect that on 22.04.2020 at about 10:45 hrs while I was on patrolling duty, found 10-12 persons consist of their 06-07 Motorcycle gathered near Monpura More. After seeing the police party 04-06 persons consist of their respective 02-03 Motorcycle were fled away. Rest persons also tried to fled away but after reached the spot we managed to detained 03 persons with their Motorcycles and 03 pedestrians also. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road or they could not able to give reasonable ground for this gathering. As such the above persons violated the order during this pandemic situation duly promulgated by Ministry of Home Affairs, Govt. of India, vide Order No- 40-3/2020-DM-I (A) dated- 15<sup>th</sup> April, 2020 to 3<sup>rd</sup> May 2020. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following 06 (Six) persons were arrested and seized 03 motor cycles from 11:45 Hrs. to 12:35 Hrs. after maintaining all formalities regarding arrest and seizure and brought them to P.S. I offered them for medical treatment but they denied.

Hence I there for pray that a specific case may kindly be started against above mentioned persons U/S 188/34 IPC & Section 54 in the National Disaster Management Act, 2005.
