Sub: Request for lodging F.I.R. against arrested accused Sarbeswar Bauri & 01 others.

Sir,

In producing here with 02 (Two) arrested accused namely 1. Sarbeswar Bauri (32 Yrs) S/O Abhaypada Bauri of Baghadabor, PS-Adra, Dist- Purulia 2. Shyamal Mahali (26 Yrs) S/O Fakir Mahali of Baghadabor, PS-Adra, Dist- Purulia along with Memo of Arrest.

I SI Parikshit Mahato of Adra PS do here by lodged a complaint against above noted 02 accused persons to the effect that on 24.04.2020 at about 18:05 hrs while I was on patrolling duty, found 10-12 persons consist of their 03-04 Motorcycle gathered at Roguri More, Adra Kashipur Main Road. After seeing the police party 08-10 persons consist of their respective 03-04 Motorcycle were fled away. Rest persons also tried to fled away but after reached the spot we managed to detained 02 persons. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road or they could not able to give reasonable ground for this gathering. As such the above persons violated the order during this pandemic situation duly promulgated by Ministry of Home Affairs, Govt. of India, vide Order No- 40-3/2020-DM-I (A) dated- 15<sup>th</sup> April, 2020 to 3<sup>rd</sup> May 2020. Accordingly the following 02 (Two) persons were arrested from 18:35 Hrs. to 18:45 Hrs. after maintaining all formalities regarding arrest and brought them to P.S. I offered them for medical treatment but they denied.

Hence I there for pray that a specific case may kindly be started against above mentioned persons U/S 188/34 IPC & Section 51 (1) (b) in the National Disaster Management Act, 2005.
