Sir,

In producing here with 04 (Four) arrested accused namely 1. Arun Mahato (45 Yrs) S/O Pathari Mahato 2. Rajesh Mahato (40 Yrs) S/O Naresh Mahato 3. Balaram Rajower (33 Yrs) S/O Khetu Rajower 4. Arjun Mahato (45 Yrs) S/O Bhajahari Mahato all are of Vill- Ranguni, PS-Adra, Dist- Purulia along with 01 seized Bicycle with seizure list and Memo of Arrest. Seized 01 Bicycle seized from the possession of him is noted below.

1. One old green color Hercules Bicycle from the possession of Arun Mahato (45 Yrs) S/O Pathari Mahato of Vill- Ranguni, PS-Adra, Dist- Purulia.

I SI Manas Kr. Panda of Adra PS do here by lodged a complaint against above noted 04 accused persons to the effect that on 27.04.2020 at about 16.35 hrs while I was on patrolling duty, found 10-12 persons consist of their 03-04 Motorcycle and Bicycles gathered at Kharai More, Adra Kashipur Main Road . After seeing the police party 06-08 persons consist of their respective 02-03 Motorcycle were fled away. Rest persons also tried to fled away but after reached the spot we managed to detained 04 persons and 01 Bicycles. On being asked the following persons could not able to give any satisfactory answer for that gathering on the road or they could not able to give reasonable ground for this gathering. As such the above persons violated the order during this pandemic situation duly promulgated by Ministry of Home Affairs, Govt. of India, vide Order No- 40-3/2020-DM-I (A) dated- 15th April, 2020 to 3rd May 2020. Accordingly the following 04 (Four) persons were arrested from 17:35 Hrs. to 18:15 Hrs. after maintaining all formalities regarding arrest and brought them to P.S. I offered them for medical treatment but they denied.

Hence I there for pray that a specific case may kindly be started against above mentioned persons U/S 188/34 IPC & Section 51 (1) (b) in the National Disaster Management Act, 2005.
