I SI, Gokul Ch Ruidas of Arsha PS do hereby lodged complaint against (1) Swarup Mahato s/o Lt Adhar Ch Mahato of Jhujka, PS- Arsha, Dist- Purulia, (2) Bijay Kuiry s/o Raghunath Kuiry of Hensla, PS- Arsha, Dist- Purulia, (3) Saroj Mahato s/o Lakhan Mahato of do, (4) Sk Abdul Samad @ Chhutu s/o Sk Belal of Bhursa, PS- do, Dist- do and others, that today (31.03.2020) at about 00:15 hrs I have got an information from an unknown caller that above persons posted “জরুরী সূচনা আমাদের আড়ষা তে একটি কোরোনা পজিটিভ কেস পাওয়া গেছে। নাম ননিগোপাল দেওঘরিয়া, বাড়ি প্রপার আড়ষা। মহারাষ্ট্রে কাজ করতে গিয়ে ছিলো। সে এখন বেলেঘাটা আই ডি তে পাঠানো হয়েছে। সুতরাং সবাই সাবধান হয়ে যান ও অপরকে সাবধান করুন একুশদিন যেনো শক্তভাবে পালিত হয়। ম্যাসেজটি ফরোয়ার্ড করুন” in different Whatsapp Groups & Facebook page malignantly, which is illegal and gives provocation to any person intending of knowing it to be likely that such provocation will cause the offence of rioting be committed in consequence of such provocation. They also disobeyed the Government Order regarding recent pandemic situation for attack of Corona virus throughout the India as well as whole World. Thus insulted the common people intentionally and thereby gives provocation to break the public peace or to commit any other offence throughout the society fully neglecting the Govt. order.

Accordingly I go through the Whatsapp groups Facebook page of them taking help of witnesses and verified the complaint and found it to be authenticated. Then I took screen shot of those pages and also made print out of those pages which are attached with this complaint.

As the above persons have committed the offence punishable U/S 188/153/504/120B IPC, so I request for starting a case and also for its investigation.
