Accordingly it is a provocation to break the public peace or to commit any other offence through out the society .

Accordingly I go through the facebook page of his taking help of witness and verified the complaint and found it to be authenticated. Then I took screen shot of those pages and also made pointout of those pages which are attached with this complaint.

As the above person has committed the offence punishable U/S- 153/504 IPC So, I request for starting a case and also for its investigation.
