Sir,

In producing herewith 01 (One) accused person namely Shaktipada Kumar (40 Yrs), S/O-Lt-Dhiren Kumar of Vill-Pathardih, PS-Baghmundi, Dist-Purulia to the effect that on 25/04/2020 at about 18:25 hrs while I SI Sudhir Kumar Mahato along with force were performing mobile duty vide Baghmundi PS GDE No- 1402 Dated- 25/04/2020 and C.C No-503/20 Date-25/04/2020 and found he roaming aimlessly at Ajodhya More area without mask or its alternative. Police party detained him at Ajodhya More on Bagmundi- Balarampur pitch road under Bagmundi PS. On being asked the above accused person disclosed his identity as noted above but could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above person violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Moreover the detained person was refuse to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic.

Hence I pray before you to start a specific case against the above noted person under proper section of law.
