Sir,

In producing herewith 02 (Two) accused persons namely 1.Nakul Rajak (22 Yrs), S/O-Nirajan Rajak of Vill-Rerengtar, 2.Amit Rajak (22 Yrs), S.O-Jagadish Rajak of Vill-Birgram both of PS-Baghmundi, Dist-Purulia to the effect that on 26/04/2020 at about 09:25 hrs while I SI Sudhir Kumar Mahato along with force were performing mobile duty vide Baghmundi PS GDE No- 1457 Dated- 26/04/2020 and found they were roaming aimlessly at Saragdih More area without mask or its alternative. Police party detained him at Saragdih More on Bagmundi- Balarampur pitch road under Bagmundi PS. On being asked the above accused persons disclosed their identity as noted above but could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 03.05.2020. Moreover the detained persons are not obeying the directions given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
