For violating lockdown order promulgated by Govt. of India & Govt. of West Bengal.

Today i.e 25.04.2020 at about 12:15 hrs I SI Sukumar Hota JC/1085 Angsuman Mandal, JC/376 Pintu Mandal, JC/378 Palash Mukherjee while was performing special Patrolling duty at Town area vide GDE No-1564 dated-25.04.2020 & CC No-1812/20 dated-25.04.2020 in order to ensure Lockdown and found the above noted arrested accused persons wandering aimlessly at Chowk Bazar area. Myself along with force detaining them at Chowkbazar More under Balarampur P.S on being asked the above noted accused persons could not provide any satisfactory reply in respect of their outing. Though the lockdown is in effect throughout the Purulia District in view of pandemic of Covid-19 outbreak vide Govt. of India Consolidated order No-40-3/2020-DM-1(A) Date-24.03.2020 & further modified dated 25.03.20, 27.03.20, 02.04.20, 03.04.20 & 10.04.20 where in it had been instructed that unnecessary movement of Public is completely restricted but violating such order, the aforesaid persons were roaming around the town area. As such their aimless & unnecessary outing without mask violated the order duly promulgated by Govt. of West Bengal vide Order No-H&FW/120/20 Dated-22.03.20 which is extended till 03.05.20 that caused difficulty to combat the pandemic like situation and increases the chance to spread infection in the society which is dangerous to life.

As such, I arrested all the above noted accused person maintaining all the guidelines regarding arrest & seized the aforesaid six motorcycles under proper seizure list duly signed by the witnesses.
